

Sabbath-Observing

In Battle Creek, Michigan, and asked for the name of the most honest man in that town. Bates was directed to David Hewitt, to whom he soon presented a Bible study on the Sabbath. Hewitt was convinced of this truth and began observing the Sabbath the next week. So did his friend, Gilbert Cranmer, the man credited with founding the Church of God movement.

As a result, for more than 150 years the Sabbath has been part of our church's history and tradition. Our denomination's Statement of Faith includes the following paragraph:

The Sabbath: The seventh-day Sabbath is God's gift to humanity from creation, was written into the Ten Commandments by God's finger, kept and taught by Jesus and observed by the apostolic church. A memorial of both creation and redemption, the Sabbath should be faithfully celebrated by believers now as a day of rest, worship, and well-doing.

Space doesn't allow for an elaborate outline of Sabbath theology with supporting biblical references. But at its core are the convictions that no evidence exists of a change of the day of rest in Scripture and that Sabbath observance does not conflict with the teaching and principles of the new covenant.

It is intriguing, therefore, to observe what may be called "a new awakening" to the concept of Sabbath in today's culture. Many are becoming increasingly aware of the essential quality and value of Sabbath rest. They're discovering that the reason God rested on the seventh day of creation is not because He was tired but because He knew how relevant Sabbath rest would be to twenty-first century humans. By resting, God underscored the "sacred rhythm" of work followed by rest and renewal. By tapping into this rhythm, we improve both our quality of life and the meaning of work. This is quickly becoming a subject of much interest in health journals, inflight magazines, books, seminars, and conferences. Setting aside a portion of time for rest, reflection, and nurturing of relationships is very much in vogue these days.

For these and other reasons, the vision of a vibrant Church of God (Seventh Day) includes "Sabbath-observing." It serves to underscore our history and to challenge us to be the grace-oriented, Sabbath-observing church for which so many yearn today. Believing that our church has been uniquely poised for this time in history, let us point our restless world to God's gift of rest in the weekly Sabbath and to their spiritual rest in Christ, to whom the Sabbath ultimately points.





Shine, Jesus, Shine

was my privilege to be part of the SHINE Medical Dental Mission 2010 on the island of Jamaica in early April. I accepted the invitation to accompany the team for several reasons, including my desire to show tangible support for this effort and to welcome these missionary volunteers to my native island. But as

it turned out, my time in Jamaica was much more than that: It was a deeply moving experience I will not soon forget.

Doctors, dentists, nurses, and support staff from the General Conferences in Mexico and the U.S. served over 1,700 patients in two locations: Spanish Town (near Kingston, the





nation's capital) and Montego Bay (on the eastern end of the island). In both places the church facility was transformed into a medical-dental clinic with equipment rented on the island and medications shipped in from the U.S.

The team's dedication and passion for people are remarkable. Their focus was not just physical, but spiritual. Ministering to the emotional needs of people and seeing some come to Christ was precious to behold. Evening services held in various locations brought team members who are ministers to the pulpit. Sabbath service was attended by some 600 brethren.

Points of Light



Doing Church Right in Lanham

The beginnings of the Lanham, Maryland, church date back to 1972 when the Perilla family (from Colombia) and the Martinez family (from El Salvador) formed a fellowship in that area. The group met in various places, including La Casa del Pueblo ("Home of the People"), a public social hall in Washington D. C., until the late W. H. Olson invited the group to share his church's rented facility in Adelphi, Maryland.

Fast-forward to May 22, 1989, a significant date in the history of this young, vibrant church: Pastor Antonio Vega arrived in the U.S. to assume the pastorate. Under his leadership, the congregation gave itself tirelessly to door-to-door outreach, street evangelism, and discipleship. A prime example of the fruit of such labor is Narciso Alberto Betances, Pastor Vega's first convert (in Maryland). He's now a leading lay minister in the Lanham congregation and area representative to the Northeastern District board.

Perhaps the most telling evidence of Lanham's visionary and evangelistic spirit is its expanding list of church plants. Satellite congregations were planted in Alexandria, Richmond, and Winchester, Virginia expanding to Frederick, Maryland, as new members were added. Financial assistance with facilities rental, equipment purchase, and pastoral services for a number of these groups are some ways the Lanham church sponsors and supports its new congregations. Assistance with leadership development and spiritual nurture is ongoing as Vega and his team travel to the various groups on a weekly rotating basis.

Back at home front, the Lanham CoG7 has become what may be the General Conference's largest congregation. After meeting in Hyattsville for several years, the group purchased its current facility (with four acres) in Lanham for \$800,000 on May 22, 2004. With some 180 adult members, plus children, youth, and regular visitors, there is standing room only during Sabbath evening services and sometimes all day in the main auditorium. For that reason, vision has been cast for building a new 700-seat sanctuary and additional offices.

Though this group dates back to 1972, its active growth began with the arrival of Pastor Vega. Amazingly, in just a little over two decades, this congregation has made giant leaps in spreading the gospel and cultivating its members and satellite plants. The congregation remains united under the skilled leadership of this 76-yearold pastor, who believes in team ministry and in developing lay leadership. Despite financial challenges, the congregation has retained Pastor Vega full time through his tenure. It has lived up to its district and Conference commitments and supported many other causes. Most important, the Lanham congregation is a point of light through aggressive gospel witness to its community and beyond.

Board of Directors: Meeting Highlights

annual meeting of the General Conference's board of directors took place February 14-17 at the Doubletree Hotel in North Denver, under the chairmanship of Loren Stacy. All members were present except for Erik Dunn, who couldn't attend due to work-related conflicts.

The Sunday portion of the meeting is reserved for presentations by Conference President Whaid Rose on the state of the Church, the implementation of the vision, board training, and other matters. Following the "State of the Church" address, Whaid unveiled a ten-year Decade of Vision Master Plan, created around the following key elements:

Refocus - bringing the big picture vision of the General Conference back into focus on all levels of the Church

Critical Success Factors - giving prioritized attention to key factors critical to the success of the vision:

Communication Leadership Development Centralization

Spiritual and Organizational Accountability

Fundraising

Culture of Excellence

Succession - making concerted efforts to recruit and groom new personnel to replace and/or fill key leadership positions

Resource-driven - securing longterm funding for ministry by building up the Conference's Endowment Fund to \$1,000,000 within the decade.

Critical Mass - building synergy by bringing together people with the needed resources in the same place at the same time

Intensity and Momentum - creating a sense of urgency and passion behind the vision

Collaboration - leaving room for key entities and individuals within the organization to give input and feel ownership in the implementation of the vision

The Master Plan will be shared

with the Church at large after further planning, prayer, and collaboration with new members of the vision team.

New staff. In keeping with the Master Plan, staff were added immediately at the Denver office. Beginning April 1, Richard (Rick) Frye (Denver, Colorado) began serving full time as IT specialist, and Abraham (Abe) Endecott (Wellman, Iowa) is special assistant to the Conference president. Beginning July 1, Dr. Richard Jensen (Walla Walla, Washington) will begin his tenure as the Conference executive director. These new staff members will be formally introduced in upcoming issues of Churchright and other publications.

New LifeSpring staff. In addition to the new staff mentioned above, LifeSpring School of Ministry is also expanding its staff as it implements Phase I of a long-term vision for the educational and spiritual development of the Church's leadership. Rocky Cardwell (also of Walla Walla, Washington) will join as IT specialist beginning July 1.

Financial commitments. The board of directors approved the Conference's budget for the new fiscal year, which includes the allocation of a percentage of tithe income received from local churches through districts for the G. C. Ministries. In addition, the board funded the following projects with funds from its designated account: IMC; additional supplement for missions budget; NAMC; digital plate processor, digital printer, and energy-efficient lighting system for Denver offices; legal fees; and supplemental funds for LifeSpring.

The board heard reports from various committees, including Endowment, and the president pro-

vided updates on various matters. It reappointed ministries directors, district superintendents, and the board of regents (replacing Loren Stacy with Erik Dunn). The board also revised the job descriptions for the LifeSpring director and regents, and transferred the supervision of the Faithful Servant Memorial and Lydy funds from North American Women's Ministries to the LifeSpring

The board granted the request of the Grand Prairie, Texas, congregation that the Conference no longer be named on its property title deed, and it dealt with other property matters. At the joint request of its superintendents, the board sponsored resolutions to be presented to the Conference in session in 2011; made a one-time grant of \$16,500 to SHINE

board of regents.

(Medical and Dental Missions), tangibly expressing appreciation for the ministry's positive impact through its witness to the gospel and commitment to missions; and changed the Conference's Vision Statement by substituting Distinct, Not Exclusive for Evangelical and Spirit-Formed for Spirit-Filled. The board also spent time reviewing the first draft of the proposed governing document prepared by one of its sub-committees, and met in executive session for the annual evaluation of the president.

The board will meet again in conjunction with the Ministerial Council in Colorado Springs this October. Pray that those you have selected to serve on this governing body will be given much wisdom and discernment as they play their role in the great cause of the kingdom.

Elroy Gold, Sr.

On February 19, 2010, Elroy Gold, Sr. lost his battle with esophageal cancer and entered his heavenly rest. He was 74.

Elroy joined the
Church in his midtwenties and served
faithfully from then
on. While working full
time in education, he
found time to devote to
ministry. Often he worked
hard all week, came home in the
evenings, and worked on a sermon to
preach that weekend.

Elroy's tireless devotion to the Church was recognized in 2003 when he and his wife, Joyce, were awarded the Churchmanship Award from the General Conference. In addition to local ministsry, Elroy was serving in his thirtieth year as a representative on the district board. For the past two years he assumed additional duties as assistant superintendent.

With hard work and his wife's encouragement, Elroy earned a bachelor's degree with certification to teach grades 1-12. He later earned a master's degree in education administration with a counselor's certification. Working with young people was a passion for Elroy at his job, at church, and at home. Countless times he helped with retreats and camps. In the early 80s he moved to Michigan, where he served for two years as principal at Spring Vale Academy.

Elroy held a lay pastor's license, and he baptized many. Among his cherished memories was baptizing one of his daughters and granddaughters. He was also honored to perform the weddings for his children and for one of his granddaughters.

Elroy will be missed by his wife of 51 years, Joyce Baker Gold, his children, grandchildren, and a host of family members. He will also be sorely missed by the Triple Tree Church of God in San Antonio, as well as by the churches he represented on the district board.
