Doing Dissolution Right:

A Tribute to the Detroit Church

happens to the assets of a local church should it cease to exist? The dissolution of a church is not uncommon. Here in the United States, churches and other non-profit entities reportedly disband almost daily. Therefore, responsible churchmanship prompts the question of what happens to the assets.

For this reason, non-profit organizations are encouraged (in some states, required) to have what is known as a dissolution statement in their articles of incorporation. Several years ago, required by the state of Pennsylvania, the General Conference added such a statement to its Bylaws, detailing the appropriate steps to be taken in the event the Conference ceases to exist. This is to safeguard against "private inurement," ensuring instead that all assets are passed on to a "like entity."

The former Detroit, Michigan, congregation is a good example of this process. The discontinuation of regular Sabbath fellowship and subsequent sale of the church building and parsonage raised questions regarding proper dissolution of the assets. Initially \$100,000 was given to Spring Vale Academy and \$10,000 to LITES. After several years, and through the careful guardianship of faithful former members, the remaining assets of approximately \$337,000

were turned over to the church's "parent entity," the General Conference. To honor the wishes of former Detroit members, an additional \$150,000 of this amount was given to Spring Vale Academy. The remaining portion was disbursed thus: \$100,000 to LifeSpring School of Ministry, \$50,000 set aside for the possible replant of a Detroit congregation, and \$37,000 for Conference use.

The Detroit congregation began in the home of Harry and Caroline Pearl (Merriam) Walkley in the early 1900s. The Walkley children include well-known CoG7 ladies: Nettie McMicken, Lillian Masters, Myrtle Brown, Ruby Boor Barraw, and Clara Decker. Other families soon joined, necessitating the purchase of a church facility. Revival services

Board of Directors Holds Annual Meeting

The General Conference Board of Directors held its annual winter meeting in Denver, Colorado, February 20-23 (noon). All members were present: Charles Carr, Erik Dunn, Jose Hernandez, Chip Hinds, Sam Holland, Wayne Hrenyk, Ruben Marquez, Carl Palmer, Raul Romo, Loren Stacy, John Tivald, and Larry Zaragoza. General Conference President Whaid Rose and Executive Director Richard Jensen were also present during most of the sessions.

As is usual during its annual winter meeting, the board of directors spent time in prayer and worship; heard and responded to the president's vision for the coming years; received and responded to information regarding General Conference ministries, districts, and personnel; considered its annual evaluation of the president's performance; and adopted a budget for the coming fiscal year. In addition, the board

- prepared numerous bylaw amendments that, if adopted during this summer's convention, will bring our bylaws and the board's commitment to policy governance into better harmony;
- dissolved LifeSpring School of Ministry's board of regents, thanking the current members for completing the purposes of that board;
- thanked Elder Bruce Noble for faithfully completing his appointed term as General Conference superintendent of our Northeastern District, and appointed Elder Sam Holland as interim superintendent for the coming year (July-June);
- placed General Conference Missions Ministries Director Bill Hicks on a fully paid, two-month sabbatical for rest, restoration, and return to ministry; and
- discussed the report of the committee appointed to study the feasibility
 of a triennial or quadrennial convention; its extensive investigation found
 virtually no support for such changes from our current biennial schedule.
 The board of directors, elected by our General Conference members, serves

as trustee of our church when the membership is not gathered to do business. In addition to being directly answerable to the membership, the board is strictly limited in what it may and may not do by our General Conference bylaws and by extensive policies that govern the board's and the president's activities. ensued and pastors were called. The Merriam, McCann, Lashbrook, Neuman, Nelkin, Starks, Otto, Willhelm, Guerra, Perez, and Roche families — among others — were added. Ministers throughout the years included William McCann, Harvey Otto, Robert Coulter, Marvin Keim, Melvin Sweet, and Bill Rice.

Throughout its history, the Detroit church purchased four properties. And though it did not have a dissolution statement in its incorporation documents, the church eventually "did dissolution right" by directing the remaining assets — the fruit of many years of service and sacrificial giving — to the General Conference for appropriate disbursement.

The General Conference takes this occasion to acknowledge the history and legacy of the Detroit Church of God (Seventh Day), grateful for all its former members, living and deceased — especially those who persevered in keeping the doors open in the final years. May the Detroit funds bear fruit for the kingdom, till Jesus comes.

The journey of the Jasper church was not a straight line, but by the grace of God, hard work, and dedication, the dream became reality. The convictions that moved its members at the beginning still inform its growing congregation today. Sabbaths still go long as members continue studying the Word, fellowshipping, sharing meals, praying, and attempting to be a caring community to the wider world around them.

Little Church in the Big Woods

The Jasper, Arkansas, congregation began in 1986 on the front porch of Ron and Vicki Overman's country-style home deep in the Ozark Mountains.

Before migrating to Arkansas with his young family, Ron had pastored the Hammondville, Alabama, church in the mid-1970s after graduating from Midwest Bible College.

This little house-church in the big woods enjoyed Sabbaths studying the Word of God, with special emphasis on Bible prophecy, current events, and conforming to the image of Christ. With singing and praying, eating and fellowshipping, Sabbath tended to go all day long, and no one was in a hurry to go home.


This small church family gathered around the idea that God was calling them to not just "go to church" a couple hours a week but to be the church as an intentional, visible counter-cultural community in the world — a "city on a hill." The church believed that it needed to recover the example of the early church in Acts 2 — a society of believers defined by daily existence, not just weekly; a community of care that shared the

Word, fellowship, prayer, meals, resources, and more.

Those in the Jasper church had been deeply influenced by the old-fashioned church campmeetings of the 60s and 70s, as well as by the neighborhood feel of the Midwest. So the question was raised "Why can't we have campmeeting year round?" Their shared dream: to build a camp people could enjoy that would also serve as the local church's home.

After several years, Jason Overman, who began serving as lay pastor in 1990, and Peter Youngs discovered property in a beautiful Ozark valley that seemed perfect but totally beyond reach. The owner, who lived in Florida, had ties to the Gainesville CoG7, and he was excited by Jasper's plan of developing a camp. He sold the 166-acre plot to the church and its families at a fantastic price.

Today the Jasper CoG7 is blessed to live and worship together around a camp facility. It also ministers to the poor and elderly through rest home visitation and music ministry, to the sick and shut-ins through Care Basket ministry, and to the needy through a food pantry.

Simulcast technology

Plans for developing Simulcast technology for LifeSpring School of Ministry have made significant progress. The new delivery model debuted on Sunday, February 13, the first full-day training session as the initial part of the pilot program.

Through this technology, Life-Spring had a single teacher in front of his own local classroom and "live" in front of the five remote sites across the country! Those in the classrooms interacted with the instructor and with each other in real time, even responding immediately to humorous comments. The simulcast technology, developed by LifeSpring's IT personnel, pulled everyone together in one virtual classroom, fulfilling the longterm goal of "bringing training to the people" in a streamlined fashion. This is one small step for LifeSpring, one giant step for the General Conference.

The technology is being perfected. Meanwhile, churches and groups wishing to host a Simulcast site should contact LifeSpring for more information.

Staff/board of regents changes

Richard Jensen has directed the affairs of LifeSpring since Larry Marrs' retirement in September of last year. Raul Lopez, Hispanic Services coordinator, is moving on to a local pastorate after an eight-year tenure with MTS/LifeSpring. Eddie Villalba now coordinates Hispanic Services. And during its February meeting, the board of directors expressed its deep gratitude for the work of the board of regents: Mary Jean Knoll (chair), Max Morrow, Joe Corrales, Calvin Burrell, and Erik Dunn. The board also relieved the regents of their assignment, considering that the current structure and operation of LifeSpring no longer requires their hands-on involvement and oversight.

Certificate of Biblical Studies

The Certificate of Biblical Studies (CBS) program is a perfect fit for anyone who would like training in the core subjects and disciplines needed for effective, life-giving min-

istry in today's church and world. LifeSpring is making the CBS program amazingly accessible:

- CBS is a 24-credit program of study that can be completed in ten months (one academic year).

Annual donations



Convention in Kenya

"Jambo!" That's how they say "hello" in Kenya, East Africa. Traveling there last December marked my first visit to that continent. There were moments of panic traveling on treacherous roads and times when I needed to make major cultural adjustments. But there were many moments of joy and inspiration as the love of Christ shone brightly on the Dark Continent.

Prior to my trip, I noted common stats about Africa: poverty, HIV/AIDS, low life expectancy rates, and the rapid spread of the gospel and growth of the Church despite these challenges. I was blessed to personally observe this paradox of hope and joy in the face of poverty and suffering. Materially, African believers have so little; spiritually, they're rich and overflowing. They can't seem to stop singing and dancing. They don't know they're poor; they have nothing to compare themselves to. Emmanuel Kant said it well: "A man is rich, not by what he owns, but by what he can live without." This is quite a commentary on the way we live in the West.

This was the first regional convention for Africa's Zone 5, attended by brethren from all over the continent and

from around the world. The US delegation included Missions Director Bill Hicks; BA Editor/IMC Vice President Calvin Burrell; Brian Baker (Colorado); Noah Cleeton (Colorado); June Bobcombe and Daisna Gibson (New York); Phyllis Weekes (Oklahoma); and yours truly. It was an enriching experience — one I will not soon forget. Pray for the Church of God (Seventh Day) in Kenya and throughout Africa, and lend tangible support by giving to G. C.
